The Certificate of Origin comprises of a three-part set as seen below:

- 1. The original certificate (white coloured sheet printed in green)
- 2. Copy of certificate (green)
- 3. The certification application form (blue coloured) which will be retained by the Chamber.

Instructions for the completion of the Arab-British Certificate are outlined on the blue application form document.


